OUR GOAL IS TO ADVANCE THE SCIENTIFIC AND MEDICAL RESEARCH RELATED TO THE DIAGNOSIS, TREATMENT, CURE AND PREVENTION OF PANCREATIC CANCER. TO WORK TOWARDS THIS GOAL, THE LUSTGARTEN FOUNDATION HAS AWARDED 205 MULTI-YEAR GRANTS TO DATE, INCLUDING 3 NEW AWARDS IN 2015, TOTALING MORE THAN \$118 MILLION. THESE GRANTS SUPPORT PANCREATIC CANCER RESEARCH PROJECTS AT MORE THAN 60 INSTITUTIONS WORLDWIDE.
